President's Message

As I look back on another year for Wasatch Peaks Credit Union, I'm incredibly proud of what we have accomplished. We have dedicated volunteers and employees who truly care about our members. The past few years have been difficult for many, with inflation and interest rates rising to levels we haven't seen in decades. Just being able to afford everyday items is getting more and more difficult...not to mention larger purchases like cars and homes. The good thing about the higher interest rates is that our members can finally earn a decent return on their deposit accounts. Certificate and money market rates have risen tremendously in recent years.

Wasatch Peaks Credit Union has \$589 million in assets, making us the 11th largest credit union in the State. We have over 31,000 members and 6 branches located in Weber County. Our net income for 2024 was \$4.39 million, and as a not-for-profit cooperative, the credit union's net income is retained as member capital or equity in the credit union. Credit unions don't have corporate shareholders to pay

dividends to...it all stays in the credit union. Our total member capital is \$61.2 million or 10.59% of our assets. According to the guidelines set forth by the National Credit Union Association (NCUA), Wasatch Peaks is well capitalized and is a safe and sound financial institution.

I would like to thank our volunteers, our Board of Directors, and Supervisory Committee, for their dedicated, unpaid service to the credit union. We also have a team of hardworking, dedicated employees who I'm grateful for. Finally, I want to thank all of you, our members. We couldn't have a credit union without you. As mentioned, credit unions are not-for-profit cooperatives owned entirely by their members. The origins of Wasatch Peaks Credit Union can be traced all the way back to 1930, when employees of the U.S. Postal Mail Terminal and the U.S. Forest Service came together to pool their resources and provide low-cost credit to each other. Even though we are much larger and more complex today, the heritage of "people helping people" is alive and well at Wasatch Peaks. Thank you all for your continued support of Wasatch Peaks. We couldn't do what we do without you.

Don't Tax My Credit Union

At Wasatch Peaks Credit Union, we have been serving our member-owners since 1930. Credit unions like Wasatch Peaks are organized and operate much differently than traditional banks. We are democratically operated and managed by a volunteer Board of Directors. We reinvest in our members in the form of lower loan rates, lower fees, and higher deposit rates. Credit union profits are retained as member equity or capital, keeping the credit union safe and sound.

Unfortunately, some for-profit financial interests and institutions are pushing to remove these benefits and protections by imposing taxes on credit unions and legislators in Washington DC are crafting new tax legislation that could impact credit unions' tax-exempt status. Credit unions are member-owned, not-for-profit financial cooperatives. Congress recognized the importance of the cooperative financial model and exempted credit unions from certain taxes in 1934. Any tax on Wasatch Peaks is a tax on you. This tax would not only harm our credit union but also directly affect over 140 million Americans who have chosen credit unions as their trusted financial partners.

Your voice is a powerful force for change. As a member-owner of Wasatch Peaks we are urging you to join us and take action today by reaching out to your U.S. Congress Representatives and Senators, advocating for credit unions by telling them "Don't Tax My Credit Union." Wasatch Peaks Commits \$2M for new OTECH Pathway Building



Wasatch Peaks Credit Union has pledged \$2 million to support the construction of a new building at Ogden-Weber Technical College (OTECH) in Ogden, Utah. This donation, along with state funding and other capital campaign gifts, will help the college complete the first new building on campus since 2011. This substantial sponsorship highlights Wasatch Peaks' dedication to education and community development, emphasizing its commitment to empowering students and enhancing financial literacy locally. The building will be named the Wasatch Peaks Pathway Building in recognition

of this significant investment in student success. The groundbreaking for the Wasatch Peaks Pathway Building is scheduled for mid-2026, with completion and ribbon-cutting in 2027-28.

The new 110,000 square foot Wasatch Peaks Pathway Building marks a significant advancement by eliminating student waiting lists, streamlining student services, and reaching more individuals seeking in-demand skills that will transform lives and strengthen Utah's workforce. The building will feature a small, high-tech Wasatch Peaks branch, state-of-the-art instructional spaces, and industry-standard labs for high-wage, high-demand programs, while consolidating student services and expanding partnerships with university partners and local school districts.

Taggart said, "This partnership hits close to home, because both Ogden-Weber Tech and Wasatch Peaks are focused on building prosperity for people right here in Weber County. The investment in student support services and world-class instructional space will change lives and provide pathways to success for decades to come. We are grateful that Wasatch Peaks is so committed to the success of current and future students and look forward to working closely with them to build additional student support resources."
